21059.1 Stillingfleet Mine Site:

To note that the 6 month period during which an appeal could have been lodged against the decision to refuse the planning application on land at the former Stillingfleet Mine site (application ref. no. NY/2016/0251/FUL) ended on 17 September 2021 and NYCC have confirmed they cannot find anything to indicate the existence of any appeal.

21059.2 SDC Local Plan – further consultation

To note the response received from Selby DC Planning to the letter sent on behalf of the Parish Council seeking reassurance that the Prime Minister's recent conference pledge, that no homes would be built on green fields, will be honoured when considering where to construct Selby's new town.
